NUECES COUNTY COMMISSIONERS COURT ORDER ESTABLISHING NEW COUNTY ELECTION PRECINCT BOUNDARIES

WHEREAS, pursuant to Chapter 42 of Texas Election Code and other applicable law, the Nueces County Commissioners Court desires to change the boundaries of county election precincts in order to comply with Chapter 42 of the Texas Election Code;


WHEREAS, section 42.006 of the Texas Election Code requires that all county election precincts have a minimum voting population of 100 and Nueces County election Precinct 126 does not reach this minimum therefore election Precincts 126 and 127 are combined and creating a new county election Precinct No. 127 indicating this to be in the best interest of Nueces County (herein "County");


WHEREAS, County election Precinct No. 125 has a population of over 5,000 and section 42.006 of the Texas Election Code requires that all county election precincts have a maximum voting population of no more than 5,000. Thus, in compliance with this section of the Texas Election Code County election Precinct no. 125 will be split into two county election precincts. Precinct No. 125 will be West of Rodd Field Rd. and Precinct No. 126 will be East of Rodd Field Rd., each having voting populations under 5,000;

WHEREAS, the Nueces County Commissioners Court determines that the interests of the people of Nueces County are best served by complying with the statutory requirements as set out in Chapter 42 of the Texas Election Code; and,


NOW THEREFORE BE IT ORDERED BY THE COMMISSIONERS COURT OF NUECES COUNTY TEXAS, that County Election Precinct No. 126 and County Election Precinct No. 127 will be combined into one County Election Precinct No. 127. Before and after maps with demographics are hereby adopted and incorporated into this Order as Exhibit "A." County Election Precinct No. 125 will be divided into two precincts down Rodd Field Rd. County Election Precinct No. 125 will be West of Rodd Field Rd. and County Election Precinct No. 126 will be East of Rodd Field Rd. Before and after maps with demographics for County Election Precincts Nos. 125 and 126 are hereby adopted and incorporated into this Order as Exhibit "B". All changes to the boundaries of these County Election Precincts shall take effect on January 1, 2016 pursuant to Section 42.033 of the Texas Election Code.
